its accounting records, authorize expenditure as per the financial regulations and properly complete periodic bank reconci	liations throughou
the year. As such, the response to Assertion 1 should have been 'No'.	

Other matters not affecting our opinion which we draw to the attention of the authority:

The smaller authority has confirmed that it has not complied with the governance assertion in Section 1, Box 4, but it has provided the appointed auditor with an adequate explanation for non-compliance and details of the actions necessary to address weaknesses identified.

In the completion of the Annual Internal Audit Report, and their detailed report, the internal auditor has drawn attention to significant weaknesses in relation to the accounting records, the authorization of expenditure and the completion of periodic bank reconciliations. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner.
