**5. Planning Consultations**

i) S/HOU/21/1043: Erection of a single storey side and rear extension at 15 Edale Moor  
No concerns raised.

ii) S/HOU/21/1377: Erection of a first-floor side extension at 35 Okebourne Park  
Councillors resolved unanimously to write to Swindon Borough Councillor C Flux to ask that this application is brought before Swindon Borough Council’s Planning Committee on the grounds this is a very large extension which is not in keeping with the estate. The extension further readily lends itself to the bedrooms being further divided and the house has a previous history with multiple occupation and has created numerous traffic and parking issues under current ownership.

Councillors resolved unanimously that Cllrs Bell and Stubbs would put together a plan for a short survey to be carried out before the next meeting.

Cllrs also raised application S/HOU/21/1415 (Erection of a detached garage (retrospective) at 111 Ashbury Avenue) and unanimously resolved to write to Swindon Borough Councillors K Parry, B Parry, and D Heenan to ask this is also brought before Swindon Borough Council’s Planning Committee on the grounds it is out of keeping with the estate and does not comply with the original planning application. Cllrs also noted further decision notices.
