**747 Declarations of Interest & Application for Dispensations.**

**748 Minutes of the Previous Meeting**

**749 Public Questions, Comments or Representations**

Eight members of Public in attendance. The members of the public raised several issues and concerns around Eldene and other areas within the Parish and the lack of works being completed by the contractor, the Clerk is to address these issues ensuring a timeframe is in place to have these issues resolved and the works completed.

**753 Liden Library Funding**

Chairman Kevin Parry advised the room that there has been an in-depth meeting regarding Liden Library and the finances, however there is still information to be obtained before an informed decision can be made. It was agreed in this discussion to defer this agenda item and to bring it back to an emergency meeting on the Tuesday 7<sup>th</sup> March 2023. The clerk to create an extraordinary meeting agenda.

- 754 S106 Parish Transfer offer to Nythe Eldene Liden Parish Council**  
The Councillors have agreed to receive the S106 Parish Transfer offer of £80,656.19 from Swindon Borough Council. The clerk to action the paperwork and to submit to Swindon Borough Council. When the funds have been received this will be added to an agenda to discuss plans and how to best consult with residents for an improved grass area outside the Eldene Community Centre.
- 755 Quote Re: St Timms Park**  
The Councillors agreed that the quote received was excessive, the clerk to obtain another quote and bring back to another council meeting.
- 756 Memorial Tree**  
The council unanimously agreed to the memorial tree, Councillor Bell and Cllr Flux suggested trees should be in all three areas (Nythe, Eldene & Liden) The location of Eldene will be the Eldene Centre area. The clerk to action the location for the other two trees and ensure these are planted by the middle to end of March 2023. The tree and materials and planting are 100% funded and comes and not cost to the Parish.

Planning permission granted for Erection of a single storey rear/side extension at 4 Bletchley Close, Eldene Swindon SN3 6BY.
